Dear Customer,

The publication of the "Candidate List" according to Article 59(1) REACH triggers a number of obligations for the European market.

Article 31(1) REACH requires among others the supplier of a substance included in the "Candidate List" to provide the recipient with a safety data sheet.

For us, this creates no additional need for action. For many years, we have provided safety data sheets for every product, even if there is no legal requirement.
