## **Declaration of Compliance**

### **for articles intended to come into contact with food**

Hereby we confirm that our product:

#### **Coffee machine WMF 5000S Item No.: 03.1910**

Complies with the legal requirements laid down in the Regulation (EC) No 1935/2004, here in particular Article 3, 11 (5), 15 and 17, the German Food and Feed Law (LFGB), the German Consumer Goods Ordinance (BedGstV) as well as Regulation (EU) No 10/2011 in their relevant versions. In addition our product complies with the requirements of the Standard DIN EN 16889 (Food hygiene - Production and dispense of hot beverages from hot beverage appliances - Hygiene requirements, migration test).

Accompanying documents and information about measures of conformity for used components and food contact materials can be provided upon request after permission of a confidentiality agreement.

The materials and raw materials that are used comply with the Regulation (EU) No 10/2011 respectively according to the latest version.

There is no indication based on the activities of conformity that the used plastics and polymers which intend to come into contact with food contain restricted substances for food (Dual-Use-Substance) above the limited values.

When used as specified, the overall migration as well as the specific migration for ceramic and plastic components does not exceed the legal limits. The tests for plastics were performed - until 31.12.2015: according to Directives 82/711/EEC and 85/572/EEC or according to Art. 17 and 18 of Regulation (EU) No 10/2011 in conjunction with Annex III and V and from 1.1.2016 according to Art. 17 and 18 of Regulation (EU) No 10/2011 in conjunction with Annex III and V.

The test for ceramic components was performed according to Directive 84/500/EEC last amended by Directive 2005/31/EC.

Under normal and reasonably foreseeable conditions of use for the above mentioned product the tests were also performed according to the standard DIN EN 16889 (Food hygiene - Production and dispense of hot beverages from hot beverage appliances - Hygiene requirements, migration test).

Furthermore the tests were performed by the expected food contact conditions regarding to temperature and duration of contact.

Depending on the type, specification and duration of the required analysis the above mentioned product is suitable for preparation of hot beverages. There is no concern associated with an intended and proper use of the product.

There is no functional barrier used in the plastic components with food contact of the coffee machine.

The product traceability in compliance with the Regulation (EC) No 1935/2004 and the good manufacturing practice (GMP) within the meaning of Regulation (EG) No 2023/2006 are ensured and guaranteed.

This declaration is valid for the product delivered by us as specified above. Under consideration of the food contact conditions stated, the product complies with the stipulations of these Directives regarding the specified foods. The user shall verify himself that the product is suitable for the intended food beyond the stipulations of the Directives.
